D Moser: Max bandwidth on Bridger Creek. The cutoff will make it an oxbow in the future.

## 310 Complaint

Application Number: GD 2C-18 Inspection Date: 03/07/2018

Alleged Violator: Canyon Adventures
Perennial Stream: Beaver Creek

Natural of Complaint: A snowmobile trail runs along Highway 191 and over Beaver

Creek. Canyon Adventures grooms the trail. They have put boards partially across Beaver Creek and brought sleds full of snow, as well as pushed all the snow in the area into the creek to create a bridge for the snowmobiles to cross. This has been ongoing all winter. Concerns are that under the right weather circumstances the creek may flood the adjacent properties because of the

ice/snow dam.

The location is to the west of the highway bridge that runs over

Beaver Creek.

Concerns also include summer activity that has caused erosion in the same area. The stream bed has been changed to make it smoother for ATVs to cross; e.g. rocks removed, trees cut.

Inspection Comments: Email comment from Dave Moser (2/07/2018): "I talked to Ray

Heagney, our trails person, he indicated this right of way trail was initially an MDT sponsored project. He also believed that the grooming crew likely is responsible for maintenance/fill. I've cc'd

Jonathan Ferree with FWP for guidance".

#### Discussion:

<u>D Moser:</u> Matt and I went there. It appears that they are pushing snow into the river just upstream of the culvert. This has become a jurisdiction question. Is it a 124 or 310 permit? This is most likely a violation. <u>L Blanksma:</u> Ed Haig with GVSA has been grooming there from his shop to the Buck Creek trailhead for the past 3-4 years. There is an ice bridge there and I think that this may be a MDOT approved project. <u>D Moser:</u> This may not be a big flood risk this year, but won't know for sure based on river water levels to date.

<u>S Leep</u> made a motion to place complaint on hold pending further information; *J Camp* seconds, motion carries

Board Decision: Place on hold

# Discussion update:

*D Moser*: Spoke with various people and this is not a MDOT approved project. It is considered a 310 violation. If he decides to clean out the ice bridge with heavy equipment, he will need a 310 permit.

*S Leep* moved to declare this a 310 violation, District to write a cease & desist letter with language that advises the violator that there could be liability if there's flooding from this action, if equipment is used for remedial action, a 310 permit will be required; *B Logar* seconds, motion carries

Board Decision: 310 Violation; Cease & Desist Letter, Visit during the summer to

view ice bridge construction for remedial course of action

## 310 New Business: Travis Horton, Montana Fish Wildlife & Parks

Cumulative Effects of Private Ponds in Southwest Montana

### <u>Private Pond History</u>

- Montana FWP has authority to permit and regulate the stocking of fish into private ponds (MCA 87-4-603).
- Montana FWP must evaluate ponds individually for the potential risk to wild fisheries and in particular native species populations.
- In 1993, the Missouri River basin was closed to new appropriations of surface water, and in the 2000s included ground water.
- In the early 2000s, MFWP and DNRC worked together to ensure private ponds had valid water rights prior to approval for stocking.
- Since the 2000s, MFWP has seen an increasing demand to develop private ponds using exempt wells.

### **Current Trend**

- Most new development of rural land in SW Montana includes private ponds
- The majority of these ponds are developed using exempt wells
- In some cases, the volume of these ponds are upwards of three times the annual volume allowed under the exempt well rules
- In some cases, landowners are developing multiple ponds on their properties; however, recent court rulings have changed interpretations of how exempt wells are addressed spatially
- Montana FWP has discovered pond stocking violations in recent years

### Fish Sources

- MFWP also regulates private hatcheries within Montana to ensure disease and Aquatic Invasive Species concerns are eliminated through annual inspections.
- In recent years, Montana FWP regulated 6 private hatcheries throughout the state that supply fish to private pond license holders.
- Problems began in the 2000s with Aquatic Invasive Species when one hatchery became positive for New Zealand mudsnails. FWP worked with that private hatchery to eliminate the risk of transport of mudsnails to waters being stocked.
- In the past 5 years, 4 private hatcheries have been quarantined due to the detection of Whirling Disease. Subsequently one of these 4 also tested positive for PKD.
- Two of the 4 quarantined hatcheries were forced to close, because they couldn't afford to make improvements needed to eliminate risks, or because they chose to not perform confirmatory testing for the parasite. Two of these hatcheries have been allowed to begin selling fish again, but at restricted levels.
- Currently, private pond owners are having to go out of state (Wyoming, South Dakota, Nebraska and Idaho)

## **Cumulative Effects Analysis**

- Organize a coalition to guide, fund and manage a cumulative effects study to advise MFWP on future of permitting ponds
- Possible participants: All R3 Conservation Districts, Northwestern Energy, Local and State Trout Unlimited, Other conservation groups (e.g., Madison River Foundation)
- Group to identify objectives of study, develop scope of work, solicit contractors, award contract, approve final deliverables, make recommendations to FWP regarding future of permitting ponds

Public Comments on District Business: Holly Hill, Greater Gallatin Watershed Council update

**BOR Drought Resiliency Plan** - Madison Boone and I will be working over the next several months to write up the final plan and will be reaching out to many stakeholders, including the CD, for feedback and input. We hope to create a plan that's valuable and useful to as many groups across the Watershed as possible.

Lower Gallatin Watershed Restoration Project Inventory - As I mentioned, we're in the process of trying to raise money to develop this project database. We will be reaching out to you in the coming months to add any project data the CD would like to incorporate. Here's a quick overview of what we envision. *Purpose:* In 2014, the Greater Gallatin Watershed Council (GGWC) worked with community stakeholders to develop the Lower Gallatin Watershed Restoration Plan (LGWRP). Since that time, multiple entities across the watershed have utilized the LGWRP to complete a number of projects addressing water quality issues, however, there is no central location or mechanism for tracking and sharing project data, making progress towards goals in the LGWRP difficult to ascertain. GGWC proposes to develop the Lower Gallatin Watershed Restoration Project Inventory to capture watershed-wide restoration project information, providing increased collaboration, information sharing and progress monitoring toward de-listing the impaired streams in our watershed. Desired data collection for the restoration project inventory includes load reduction estimations, miles restored, project costs, volunteers engaged, partnerships developed, project successes and challenges and opportunities for additional work.

We'd love to hear any feedback you have, if this would be a useful tool for you and your Board and what types of information you'd like to see incorporated.

**Spring River Cleanup** - We'll keep you posted on whether we decide to host a Spring Cleanup in addition to our Fall Cleanup this year, but we'd love to know if there are there sections of the Gallatin in your area that you're aware of that need some TLC? Could the Four Corners Fishing Access Site use some volunteers to pick up trash?
