D Moser: The culvert that was installed was undersized, but functioning. It could use small rip rap by the culvert. The bed elevation is close to the stream bed. I'm comfortable with applicant trimming the willows and removing debris.

B Logar: Is this a fish bearing stream?

D Moser/R Laden: Yes, it's a meadow stream.

R Laden: The stream used to cross the road, but they straightened it. They also raised the road, it used to flood before. I'd like to dig out the moss in the channel. It's a real shallow stream.

S Leep: Are you proposing two projects? What's the distance between the two?

R Laden: Yes, two projects. About 1/8 mile apart

D Moser: Bank restoration may be needed.

M Rotar: Matt recommended not getting carried away clearing vegetation.

B Logar: Would you recommend not widening the right side of the channel?

D Moser: There would be a potential for more problems. I recommend that the county install a larger culvert.

C Mahony: Any recommendations to help mitigate stream moving into the borrow pit?

M Rotar: It's small enough that bio-engineering, small rocks 3-10" cobble with willows, might be used instead of widening stream.

J Camp: That will need to be a separate application.

R Laden: That area is the Simpkin's property, not mine.

Inspection Comments: The west portion of the bridge support has been undermined /

eroded causing that side of the structure to fall into the creek. It does not appear to be an emergency situation since the likelihood of it breaking up, flowing downstream, and plugging something else seems low since the stream is relatively small and the steel deck and beams appear to be securely fastened making one solid structure. Currently, there is debris that has accumulated on the upstream side of the bridge causing backwater and flow is going around the edge adjacent to the failed abutment. Recommended action would be to notify landowners of the situation and that the bridge will need to come out and the banks restored during low

flow.

Discussion:

D Moser: Doesn't appear to be a risk of the bridge washing downstream, it's still attached on one bank. *M Rotar:* Maybe there's an absentee owner. A lot of sediment will wash downstream if the bridge fails.

S Leep: Is this an instream pond?

D Moser: Doesn't appear to be an instream pond. L Blanksma: Access road? Where does the road go to?

D Moser: Road to nowhere, maybe an old property, discontinued use.

M Rotar: Google Earth map shows another access road can be used to reach properties beyond this

unused bridge. *S Leep* made a motion to declare this a 310 violation and to send a letter advising violators to cease and
