Purpose: Removal of a large log jam on Middle Creek. This log jam has water backing up in the stream for approximately 200 yards. Current levels have the stream flowing around this obstruction, however with higher stream flows expected in the next few days, it will cause flooding. The major emergency is the possibility this jam will release with

increased stream flow and will cause major damage to the West Gallatin Canal flume, which crosses Middle Creek below this obstruction. Removal will eliminate the ponding of the stream behind it and remove the possibility for major damage downstream.

This action was taken due to increased flows from Hyalite Reservoir expected in the next couple of days. This will cause increased stream flows which will make it very difficult to correct this problem.

Action Taken:

An excavator will be used to remove the debris from the stream with little in stream work and minimal stream bed disturbance. Landowner permission has been granted to the company to remove this obstruction.
